It is appointed for four years and comprises twenty experts from academia, foundations and civil society organizations. It follows the implementation of the Federal Government's guidelines on "[Preventing Crises, Resolving Conflicts, Building Peace](#)" published in 2017.

The Advisory Board fosters constant exchange between the Federal Government and civil society. It publishes positions on overarching strategic questions. In addition, it develops contributions on pertinent issues.
