Advisory Board to the Federal Government Civilian Crisis Prevention and Peacebuilding

By bringing together expertise on crisis prevention and peacebuilding from both civil society and academia, the Advisory Board supports the Federal Government in these areas. It is appointed for four years and comprises twenty experts from academia, foundations, and civil society organisations, police and the military. It follows the implementation of the Federal Government's guidelines on "Preventing Crises, Resolving Conflicts, Building Peace" published in 2017. The Advisory Board fosters constant exchange between the Federal Government and civil society. It publishes positions on overarching strategic questions. In addition, it develops contributions on pertinent issues.

The world is undergoing a period of profound geopolitical and social upheaval. Growing geopolitical rivalries are compounded by social polarisation, authoritarian tendencies, hybrid threats and unresolved conflicts. At the same time, the need for effective civilian conflict management and peacebuilding is increasing, while the multilateral, national and local structures on which these efforts have traditionally relied are coming under growing pressure.

Against this backdrop, the Berlin Peace Dialogue 2026 focuses on international and global partnerships for civilian conflict management and

peacebuilding. As established forms of multilateral cooperation increasingly reach their limits, new forms of cooperation are emerging – more flexible, issue-specific and often rooted in regional and local contexts. The conference explores how partnerships can be built across different political systems and approaches, which instruments and alliances can contribute most effectively to peace and social resilience, and how cooperation can respond to both global and local challenges.

For Germany and Europe, these developments call for a more strategic and politically coherent approach to international cooperation. This includes strengthening partnerships beyond traditional alliances, engaging constructively with a diverse range of actors, and exploring new forms of cooperation in response to emerging challenges.

The central questions of the Berlin Peace Dialogue 2026 are: **How can Germany and its partners build effective and resilient forms of cooperation for civilian conflict management and peacebuilding in a changing geopolitical landscape? And how can the concepts and instruments of peacebuilding respond to increasingly interconnected global and local challenges?**
